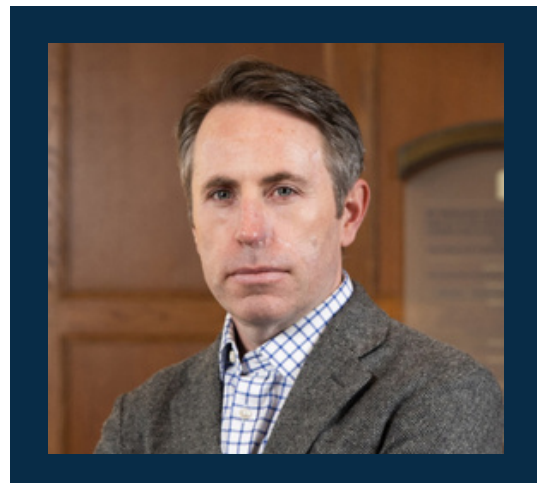
## H. George Frederickson Award for Career Contributions

**Donald Moynihan**, J. Ira and Nicki Harris Family Professor of Public Policy, University of Michigan Gerald R. Ford School of Public Policy

PMRA is pleased to announce that Professor Donald Moynihan has been selected as the 2026 recipient of the H. George Frederickson Award, which honors a scholar whose career represents a sustained and significant contribution to the intellectual development of public management research. The selection committee emphasized sustained intellectual contributions to the field's core questions, clear influence on other scholars, and proven application across diverse contexts. Professor Moynihan's research on performance management reshaped how scholars and practitioners think about the use of performance information in public organizations, and his work on administrative burden has become one of the most generative

research agendas in contemporary public administration - applied by scholars globally across welfare administration, voting access, and health policy, and influencing guidance from the U.S. Office of Management and Budget.

A past president of both PMRA and APPAM and co-director of the Better Government Lab, Professor Moynihan has also invested deeply in the professional life of the field through mentorship, journal service, and his widely read *Can We Still Govern?* newsletter. He exemplifies the sustained, field-shaping career the Frederickson Award was established to honor.



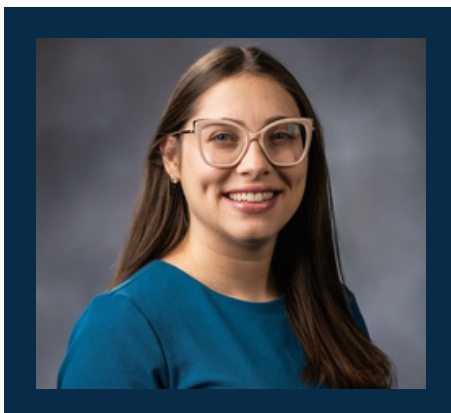

PMRA congratulates Dr. Marylis C. Fantoni, recipient of the 2026 Best Dissertation Award for Channel, Communication and Composition: Improving Reporting of Domestic Violence. Drawing on comparative evidence from Rio de Janeiro, Brazil, and the State of Indiana, the dissertation applies administrative burden theory and cutting-edge causal methods to demonstrate how reporting channels, communication framing, and the gender composition of the judiciary each shape outcomes for survivors of domestic violence.

The selection committee recognized Dr. Fantoni's work as a rare combination of theoretical innovation, methodological diversity, and real-world impact. ## Beryl Radin Award - Best Article in JPART

The Beryl Radin Award is given annually to recognize the best article published in the Journal of Public Administration Research and Theory, honoring the legacy of Dr. Beryl A. Radin, one of public administration's most distinguished scholars. Articles are evaluated on scholarly contribution, theoretical advancement, methodological rigor, and relevance to public management research.

### Winner:

**Florian Keppeler, Jana Borchert, Mogens Jin Pedersen, and Vibeke Lehmann Nielsen** for **"How Ensembling AI and Public Managers Improves Decision-Making"** (JPART, Vol. 35, No. 3, July 2025, pp. 261–276). This timely and rigorously designed study investigates how combining artificial intelligence with the judgment of public managers produces better decisions than either approach alone. The selection committee recognized it for its empirical rigor and its direct relevance to one of the most pressing governance challenges of our moment.

### Honorable Mention Kirstine Karmsteen

Kirstine Karmsteen for "Making Administrative Work Matter in Public Service Delivery: A Lens for Linking Practice with the Purpose of Office" (JPART, Vol. 35, No. 1, January 2025, pp. 15–28).

The committee commended this article for its conceptual originality in connecting frontline administrative work to broader institutional purposes — a contribution with clear value for both researchers and practitioners.

## Camilla Stivers Award - Best Article in PPMG

The Camilla Stivers Award is given annually to recognize the best article published in *Perspectives on Public Management and Governance*, honoring the contributions of Camilla Stivers, a pioneering scholar whose work challenged the field to grapple seriously with questions of gender, democratic citizenship, and the meaning of public service. Articles are evaluated on originality, analytical rigor, contribution to governance scholarship, and relevance to public management research.

Winner: **Maeve Curtin** and **Caitlin McMullin** for "The Co-Production Spectrum: Conceptual Blurs in Theory and Practice" (*Perspectives on Public Management and Governance*, Vol. 8, No. 3, September 2025, pp. 144–157). Curtin and McMullin critically examine the conceptual boundaries of co-production, identifying how ambiguities in theory translate into uneven and inequitable practice. The selection committee recognized this article for advancing scholarly clarity in a consequential area of public management while centering questions of participation, power, and access.

## Riccucci-O'Leary Award - Best Article on Diversity in JPART or PPMG

The Riccucci-O'Leary Award is given annually for the best article on diversity, broadly defined, published in JPART or PPMG, honoring the contributions of Norma Riccucci and Rosemary O'Leary, two scholars who have shaped the field's understanding of diversity, management, and public service.

### Winner:

**Pamela Herd** and **Donald Moynihan** for "**Gendered Administrative Burden: Regulating Gendered Bodies, Labor, and Identity**" (Journal of Public Administration Research and Theory, Vol. 35, No. 1, January 2025, pp. 45–57).

Herd and Moynihan extend administrative burden theory in a powerful direction, demonstrating that burdens are not neutral but are systematically structured along gendered lines — shaping whose bodies, whose labor, and whose identities are subject to government

regulation and compliance demands. The committee recognized this as a landmark contribution bridging public administration with broader conversations about gender, equity, and state power.

Note: Professor Moynihan is also this year's recipient of the Frederickson Award for Career Contributions — a reflection of the remarkable breadth and impact of his scholarly work.

Given every three years, the award recognizes the best article published in JPART or PPMG that advances knowledge of public management in the Global South, reflecting Professor Avellaneda's commitment to centering the scholarship and governance challenges of developing and emerging nations in our field.

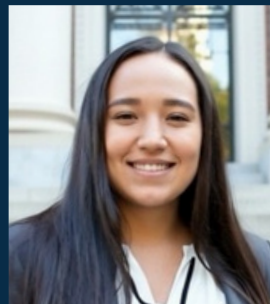

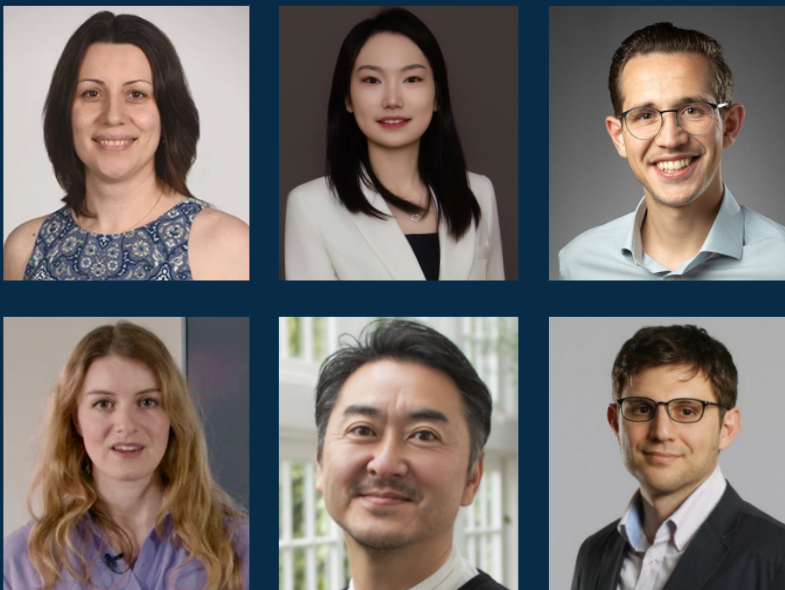

## JPART Artificial Intelligence Message

**JPART update: Maintaining academic quality in the age of generative AI**

The use of generative AI in academic writing is now real, widespread, and rapidly increasing. Across the field, colleagues are seeing it, discussing it, and trying to understand its implications for our profession. At JPART, the numbers speak for themselves. Just a few years ago, the journal received just under 600 submissions annually. This year, we expect to receive over 1,200. Based on our day-to-day handling of manuscripts, and on what we hear from colleagues across the field, we have little doubt that this sharp increase is largely driven by the growing use of generative AI.

More specifically, we now regularly encounter manuscripts that appear to have been heavily edited or even partially or fully created by AI tools. They are, at a surface level, well constructed and well written, but often do not withstand closer examination. The language is often over-refined. Sentences follow similar patterns. Paragraphs may use elaborate or “fancy” phrasing but lack a clear, forward-moving argument. We also see

recurring stylistic markers, including University terms, punctuation, and phrasing, that suggest strong reliance on AI-assisted writing. This is not limited to isolated cases; it is becoming a broader pattern. Like other major journals, we now see AI content in submissions on a daily basis.

For the field of public administration and management research, and for academic publishing more broadly, the concurrent increase in submission volumes and rapid development of AI tools present a serious challenge. Editorial and reviewer time has always been the bottleneck of academic quality assessment. When the volume of submissions increases rapidly, in large part driven by AI generated text, that system comes under pressure. There is a real risk that it begins to break down. We already see signs of strain in some journals, where decisions can appear inconsistent or difficult to explain, as editors and reviewers struggle to keep up with the pace of submissions. This is not a race we can win by simply working harder, especially as AI tools continue to improve. Moreover, we view it as imprudent to respond to automation of content creation by merely automating its evaluation.

## JPART Artificial Intelligence Message

In the JPART editorial team, we have made a decision to explore options for handling the large increase in (often AI-generated) submissions. Other journals are using measures such as caps on submissions, submission fees, and more systematic screening for AI-generated content, among others. The JPART team will not develop these approaches in isolation but will seek to learn from leading journals in related fields and will work closely with the scholarly community and PMRA leadership.

We have one goal with these initiatives: to maintain and strengthen JPART as a trusted platform for high-quality research. In a context where the volume of content is increasing and quality is becoming more uneven in ways that may be difficult to spot, it is more important than ever that the people we serve, our authors and readers, can rely on the journal as a place where manuscripts are carefully assessed and selected for publication by experienced editors and reviewers.

For authors, the message is straightforward. If you submit a manuscript of high quality, within JPART's aims and scope, and one that you take intellectual ownership of as a

researcher, we will evaluate it carefully. We will try to provide constructive feedback and, if the paper meets the standard, we will publish it. Our efforts are also intended to protect our reviewers. The reviewer pool is a scarce and valuable resource. It is important to us that the manuscripts we send out for review meet a standard that justifies the time and effort of reviewers. As editors, we take seriously our responsibility to filter submissions before they reach you.

We anticipate that not all initiatives will work equally well, but doing nothing is not an option. Some measures may work better than others, and we will work closely with the PMRA community and leadership in assessing what works and what does not work. We hope that all of you, our authors, readers, and reviewers, will approach these efforts with an open mind and share your ideas for supporting and advancing JPART in the age of generative AI. We warmly welcome your thoughts and ideas and encourage you to use the upcoming PMRC in Washington, D.C., to share your input with us.
